

CERTIFICATE OF COMMITMENT AND KNOWLEDGE FOR THE ACQUISITION OF A DOG

Compliant with L214-8V and D214-32.4 of the 'code rural et de la pêche maritime'

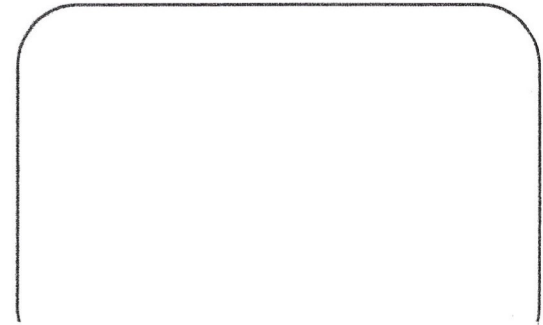


- Acquiring a dog is a long-term commitment, which must be thought through and accepted by all members of the household, who must all ensure that the animal does not suffer in silence.
- A dog is a social species. They must spend time with their fellow human beings and exert themselves according to their state of health and age.
A dog requires my availability as well as daily outings.
- A dog must be included and loved in conditions compatible with the characteristics of its species and its breed.
- For this, I undertake to follow the advice of the breeder relating to my dogs good physical and psychological development, contained in the information document which is given to me at the time of the transfer.
- A dog must be educated. For this, I will use the services of a professional trainer, who respects the physical, mental and emotional integrity of my dog without using tools and methods that contradict this.
- A dog must be fed daily and with sufficient food adapted to its size and its age. It must permanently have clean and fresh water; I will therefore provide an annual budget for its routine maintenance (food, accommodation, activities and veterinary care). This budget is in accordance with the decree of July 31, 2012 and as provided to me in the information document.
- My dog will be regularly monitored in order to carry out booster vaccinations and referred to a veterinarian in the event of apparent illness or doubt as to a health problem or suffering. I have the possibility of subscribing to a mutual health insurance for a portion of these costs.
- A dog must be treated regularly to prevent internal and external parasites.
- It is advisable to have my pet sterilized and for this, I will contact a veterinarian.
- My dog is identified by chip (transponder) or by tattoo reference to the I-CAD company which manages the national register of domestic carnivores. I undertake to report any new event to I-Cad without delay: change of address, change of holder, declaration of loss to theft, or death of the animal.
- In the event of absence, hospitalization or vacation, I must plan for my dog to be looked after and for that I could use a professional canine boarding place.
- I am responsible for my animal and the damage it could cause. As soon as my dog is acquired, I will declare it to my civil liability insurer.
- My dog should not be left straying. I know that this constitutes a criminal offense that can attract up to 1 year in prison and a €15,000 fine.
- Abandoning an animal is illegal and punishable by 3 years in prison and a fine of €45,000. In the event that I cannot keep my animal, I undertake to notify my breeder and to take all measures to find a responsible family for my animal and, if necessary, I will contact a shelter or an animal protection association.
